The bill is not very clear as to why we are purchasing so many tickets, the advisor letter is rather choppy in wording, and the club representative has been contacted in an attempt to get answers. I am also concerned has to know the tickets will be distributed or why they submitted the bill with only 3 days before their first performance.

**Senate President:** Previously, IAP has asked for funds through allocation and we have constantly asked that they have a card swipe present. They have failed to have a card swipe and just do a head swipe of what appears to be typical ASU college students.
